Owner shall pay Triple 7 Ranch for:

Boarding and Training fees are due the 1st day of each month that the above named horse is in the care of Triple 7 Ranch. First partial month will be prorated, and the first full month training and board is to be paid in advance. Beginning the second full month of boarding/training all fees are due on the 1st day of the month.

Invoices will be mailed by the 15th of the month for pre-payment of the following month.

If accounts go unpaid by the tenth day of the month a 10% late fee of boarding and training expenses will be assessed. Accounts past due by 2 months will have the above named horse sold for money owed.

ADDITIONAL FEES

I agree to pay all additional fees which may include but are not limited to emergency veterinarian fees, transportation of horse, Ferrier services, as well as miscellaneous costs and expenses.

Destruction to ranch caused by customer's horse will be billed at cost for repairs.

I hereby grant a lien to Triple 7 Ranch on the said horse, for all unpaid fees.

HORSE HEALTH

The horse shall be free of infectious, contagious, or transmissible disease. If the above named horse is found to be infectious, and you fail to inform trainer, and other stabled horses become infected with the same symptoms, the owner of the infectious horse will be held liable for any and all veterinarian bills and/or the death of other horses infected that resulted from the transmission of the disease or parasite originating in the above named horse.

Trainer reserves the right to notify the owner within seven days of the horses' arrival if horse, in trainer's opinion, is deemed to be unhealthy or too dangerous for trainer to handle and train. Owner is responsible for recovering horse immediately and for paying all fees incurred.

If owner wishes for horse to be blanketed/sheeted, a blanket and/or sheet must be provided by owner, for each horse.

TERMINATION OF CONTRACT

Owner will give a written 10 day notice to Trainer of termination of this contract, if termination is to take place before the preset end of training/boarding date.

Written notice can be in the form of an email, text, handwritten or typed note.

Regular charges will paid by owner of above named horse through the contract termination date.

LIMITATION OF LIABILITY AND INDEMNIFICATION.

Triple 7 Ranch, and its subsidiaries, affiliates, agents, servants, and employees shall not be liable for any sickness, disease, astray, theft, death or injury that may be suffered by the above named horse while with Triple 7 Ranch, employees, or agent, nor for any loss, damages, or injuries arising out of, or connected with conditioning, training, boarding, or other services pursuant to this contract. Customer fully understands, authorizes and assumes the special risks inherent in conditioning, training, boarding, transporting, and showing horses and acknowledges that mortality and other insurance is solely the customer's responsibility. All implied warranties, including fitness, merchantability, worth, or otherwise and all special incidental and consequential damages are hereby excluded. Any refunds or credits that are given will be at the discretion of Triple 7 Ranch.

Training Contract

This Training Contract is made and entered into this _____ day of _____, 20____, by and between Laurel Carlock, of Triple 7 Ranch, hereinafter designated "Trainer" and _____, hereafter designated "Owner". Trainer agrees to accept owner's horse _____ for training; and, it is the plan and the intention of the owner to contract for training of the horse. Trainer and owner mutually agree to the following:

1. Owner agrees that the trainer is not liable for death, sickness, and/or accident including consequential damages caused to the horse while in training, except if caused by the willful and wanton negligence of the trainer. In addition, owner agrees to hold trainer completely harmless and not liable for any injury whatsoever caused to the owner, and/or any loss or damage to personal property. It is the responsibility of the owner to carry full liability and mortality insurance coverage for his/her horse, person, and personal property.

2. Trainer has the authority to contact a veterinarian for emergencies/regular care and owner will be liable for veterinarian's charges. _____ (initial's of owner)

4. Trainer reserves the right to determine the best type of training and tack to be used. (The owner is welcome to make suggestions, but ultimately the trainer will use what the trainer determines to be in the best interest of each individual horse)

5. At the end of training it is highly recommended that the owner take part in a free "owner training lesson" to: learn what the horse has learned, as well as how to communicate with the horse. Your horse will require ongoing regular training by the owner to:

1. **Earn the horses respect**
2. **Keep the horses training fresh**
3. **And further the horse's training.**
